



## **Vendor Agreement**

Between

MDG Online Services Pvt. Ltd. (hereafter referred to as "MyDailyGoods")

[Vendor Name] (hereafter referred to as "Vendor")

The agreement is considered accepted by vendor as the accept MyDailyGoods terms and conditions.

### **1. Purpose**

This Agreement governs the relationship between MyDailyGoods and the Vendor for listing, selling, and promoting the Vendor's products through MyDailyGoods' e-commerce platform and mobile application.

### **2. Eligibility**

The Vendor must be:

- An individual or business entity legally eligible to sell in India.
- Either registered under GST or enrolled with a UID (Unregistered Dealer ID) if turnover is below the threshold limit or selling within the same state.

### **3. Vendor Responsibilities**

The Vendor agrees to:

- Upload accurate product details, prices, and images.
- Dispatch products on time and handle returns as per their policies.
- Ensure legal ownership of products listed.
- Maintain compliance with all local/state/national laws.

### **4. GST / UID Compliance**

- Vendors selling within state limits and with annual turnover below ₹40 lakh (₹20 lakh for services) may operate with a UID (Enrollment ID).
- For interstate sales, Vendors are mandated to obtain a GST registration.
- Vendors shall update their UID/GSTIN on their MyDailyGoods dashboard.
- Vendors are solely responsible for filing GST returns, if applicable.

## 5. Pricing & Charges

- With no home delivery or vendor self managed shipping , COD means that the vendor will collect money on their own direct from the vendor and thus, MyDailyGoods will not collect any TCS for the same. Full amount will be kept by the vendor.
- Product prices listed must be inclusive of GST, TCS, packaging, shipping, and payment gateway charges.
- MyDailyGoods charges a 0% commission, but may collect a 1% TCS as mandated under Section 52 of the CGST Act.
- All payments will be settled after deduction of TCS, payment gateway charges, and other applicable platform fees (if any).
- Payment gateway charges and TCS (total max. 5%) are deducted and rest order amount is transmitted to vendor in less than 2 business days as per T2 cycle.
- MDG Delivery provides option to connect to different delivery partners through companies like ship rocket and shipping company list may change.
- In case of MDG Delivery, the shipping charges will be added to order value and customer will pay the shipping as per other shipping rules (in case set free after a specific order value).
- Shipping charges will also be deposited in vendor's account. Once they ask delivery boy for pick up the shipping charges will get deducted from their shipping account.
- With MDG Delivery for COD orders the amount will be directly deposited by the shipping company after collection from the customer as per shipping company rules.

## 6. Payment & Settlements

- Payment shall be disbursed to the Vendor's bank account through split settlement or other available methods.
- Invoices will be auto-generated from the dashboard under vendor's name. Vendors can download them for accounting purposes.

## 7. Promotions & Coupons

- Vendors are encouraged to create and share dynamic discount coupons via WhatsApp and other social platforms to attract customers.
- The platform may promote Vendor shops through SEO, Google Search, and influencer campaigns.

## 8. Termination

Vendor could terminate account just by making shop offline.

MyDailyGoods could terminate vendor account if finds vendor participating in any false practices which are not justified under Indian law or if selling any goods which needs any

approval or certification or prescription and are not allowed to be sold online without fulfilling requirement.

### **9. Data Sharing & Privacy**

- Vendor and customer details will be transparently shared with each other after purchase.
- The platform will not sell or misuse personal data of vendors or customers.

### **10. Dispute Resolution**

Any disputes arising from this Agreement shall be subject to the jurisdiction of the courts in [Meerut, India].
